22 1. I am an adult resident of the State of Arizona.

1 12. It will be increasingly difficult for me to obtain another job because
2 ultimately, the longer a pilot is away from flying the harder it is to ever obtain another
3 flying job. This is due in part to the lack of currency and proficiency described above.

4 13. I am losing salary and benefits that support a family of four. I will miss
5 Q4: my 401k will be vested at 3 yrs instead of 4 yrs. I am losing my life insurance.
6

7 14. There is a strong possibility I could lose my home, which would be
8 especially devastating in this market.

9 15. The furlough has caused me and my family a lot of stress and sleepless
10 nights due to the pure uncertainty of unemployment. I may have to move my family,
11 displace my children from school, and experience additional reductions in the quality of
12 our lives.

14 16. Additional harms resulting from furloughs and downgrades to any pilot
15 include degraded schedules – senior pilots who used to be able to hold weekends off no
16 longer can, they can no longer hold desirable overnights, can't hold higher paying lines,
17 can't hold their desired days off. I have lost all of these benefits as well.
18

19 17. Additionally, vacation bids for next year closes Nov 8. Those on furlough
20 will not be allowed to bid. Those that do get to bid for vacation will not be able to hold
21 the vacation schedule.


