>> It has come to my attention that former CA rep [REDACTED] is calling
>> committee chairs and soliciting their support for him to be the
>> appointed (not elected) USAPA rep in PHX.

>> I continue to be concerned that [REDACTED] is attempting to rationalize
>> this action by stating that USAPA may change their CBLs. During 3
>> years of dealing with the east, I observed many promises from the east
>> leadership - most of which rarely came through.

>> I am highly concerned that anyone cooperating with USAPA will be
>> paraded in front of a federal judge as evidence against any DFR suit
>> brought against USAPA.

>> If the UAL merger takes place, we will be back in ALPA in very short
>> order (my current estimate in Jan/Feb 09 - possibly earlier). There
>> will be no card collection and ALPA can file for an election dispute
>> the day after the deal closes. Then it will be up to the NMB to sked
>> an election and my guess is that will take 2 months or so.

>> I think that is important that while I understand pilot's wanting to
>> help their fellow AWA pilots in any way they can, there are better
>> ways to do this than by becoming a USAPA "vichy" stooge, and
>> attempting to rationalize this action.
