1 Defendant, the US Airline Pilots Association (“USAPA”), files this supplement to
2 its motion (Doc. # 17) to stay all further proceedings, in order to alert the Court to a
3 development that occurred following the service and filing of USAPA’s motion. In its
4 memorandum supporting the stay request, USAPA informed this Court that pending
5 before the Ninth Circuit Court of Appeals was a request to stay issuance of the Ninth
6 Circuit’s mandate in *Addington v. US Airline Pilots Ass’n*, 606 F.3d 1174 (9th Cir. 2010).
7 (Doc. # 18 at 1).

9 On August 3, 2010, the Ninth Circuit Court of Appeals ruled to **deny** the
10 Addington plaintiffs’ (here defendants) motion to stay issuance of the mandate (*See* Doc.
11 # 19-2). That ruling is attached to this Supplement as Exhibit A. The Addington
12 plaintiffs’ time to petition the Supreme Court for a writ of certiorari continues to run.
