1                   **PLEASE TAKE NOTICE** that Plaintiff US Airways, Inc. (“US Airways”)  
2 respectfully submits this statement in support of the Addington Defendants’ Amended  
3 Motion for Class Certification, dated June 24, 2011 [Doc. No. 91].

4                   For the reasons set out in its Complaint for Declaratory Relief, dated July  
5 26, 2010 [Doc. No. 1], US Airways agrees that this Court should certify a defendant class  
6 comprised of “[a]ll pilots employed by the airline US Airways in September 2008 who  
7 were on the America West seniority list on September 20, 2005” (the “West Pilot Class”).  
8 (*See Addington v. US Airline Pilots Association*, Case No. CV 08-1633-PHX-NVW,  
9 Order dated March 10, 2009 [Doc. No. 248], at pp. 1-2.) In light of Defendant USAPA’s  
10 Response in Opposition to the Addington Defendants’ Motion for Class Certification,  
11 dated June 27, 2011 [Doc. No. 92], US Airways will shortly file a motion of its own  
12 requesting certification of the West Pilot Class under Federal Rule of Civil Procedure  
13 23(b)(1) and 23(b)(2).
