Soha, Rodney Albert Brackin, and George Maliga, as named parties to represent the West Pilot Class that was certified by the Court on November 2, 2011 (Doc. 125).

1. Michael J. Soha is number 10 on West seniority list, 552 on the Nicolau List. Captain Soha flies the B-757 and resides in Washington State.

2. Rodney Albert Brackin is number 123 on West seniority list, 900 on the Nicolau List. Captain Brackin flies the B-737. He is a check airman and maintenance test pilot and resides in Arizona.

3. George Maliga is number 350 on West seniority list, 1547 on the Nicolau List. Captain Maliga flies the B-737 and resides in Arizona. He is well acquainted with this and related litigation between West Pilots and USAPA. He attended nearly every hearing in these cases including the Ninth Circuit appellate argument. He has close friendships with many West Pilots who are working to protect West Pilots' seniority rights.

Undersigned counsel affirms that these three proposed representatives have been apprised of the duties of a class representative, understand those duties, and agree to be representatives. In addition, undersigned counsel consulted with counsel for US Airways and USAPA and is authorized by them to state that their clients do not oppose this motion. The Addington Pilots, therefore, respectfully ask the Court to enter an order joining Rodney Albert Brackin, Michael J. Soha, and George Maliga as representatives of the West Pilot Class.
