The Constitutional Amendment on the Dissolution of USAPA Referendum

### **FAILED**

due to a lack of receiving a two thirds (2/3) majority of the eligible votes cast.

The USAPA Constitution and By-Laws, Article XIII, Sec. 2. B. states:

#### 2. Amendments Initiated by the Board of Pilot Representatives

b. In order to amend the Constitution, the amendment shall be ratified by two thirds (2/3) majority of the votes cast by the membership provided that a majority of the total membership casts ballots in the referendum on such amendment(s).

**PHX TOTAL**

- There were 3964 eligible voters, of which 2427 cast a ballot, representing 61.2% of the eligible voters.
- Of the 2427 ballots cast, 548 (22.6%) were by phone, and 1879 (77.4%) were by Web.
- There were 0 ballots cast in which the voter did not make a selection.
- There were 16 ballots declared void.
