**DEFENDANT US AIRWAYS, INC.'S
RESPONSE TO PLAINTIFFS'
MOTION TO TRANSFER CASE**

1 Plaintiffs have filed a motion to transfer this case to Judge Silver or Judge Wake
2 pursuant to LRCiv 42.1(e) (Doc. No. 5), and Defendant US Airline Pilots Association
3 (“USAPA”) has filed a motion seeking an extension of time to respond to Plaintiffs’
4 motion and to the Complaint as well (Doc. No. 9).

5 Defendant US Airways remains neutral as to the merits of the seniority dispute
6 between Plaintiffs and USAPA that lies at the heart of the instant lawsuit. It does,
7 however, have an interest in the prompt resolution of the merits of this dispute.
8 Accordingly, if the Court determines that transferring this case to either Judge Silver or
9 Judge Wake would facilitate a more expeditious resolution, US Airways supports such a
