4 trial, the parties stipulate and request that the Court modify certain deadlines set forth in
5 the Scheduling Order (Doc. 160) as follows:

- 6 • Deadline for completion of discovery (Paragraph F of the Scheduling Order):
7 September 30, 2013;
- 8 • Paragraph G of the Scheduling Order is amended to read as follows: The parties
9 shall finally supplement responses to all discovery including material changes in
10 expert witness opinions and material disclosures relating to the expert witnesses
11 on or before October 2, 2013. The parties agree that FRCP 26(a)(3) disclosures
12 are not required in this matter given the current trial date of October 22-23, 2013.
- 13 • Deadline for filing dispositive motions (Paragraph L of the Scheduling Order):
14 October 11, 2013;
- 15 • Deadline for lodging of Joint Proposed Pretrial Order and deadline for filing Joint
16 Statement of Undisputed Facts, Joint Statement of the Case, Independent
17 Statements of Disputed Facts (Paragraph N of the Scheduling Order): October 9,
18 2013 with parties to exchange initial drafts on or before October 1, 2013;
- 19 • Deadline for filing Motions in Limine (Paragraph N of the Scheduling Order):
20 October 11, 2013;
- 21 • Deadline for filing Proposed Findings of Fact and Conclusions of Law (Paragraph
22 O of the Scheduling Order): October 14, 2013.
