1 Defendant US Airline Pilots Association (“USAPA”) hereby withdraws and  
2 notifies the Court that USAPA is withdrawing its Motion to Transfer Venue (Doc. 26)  
3 and its Motion to Suspend Deadlines until 14 Days Following the Ruling on the Motion  
4 to Transfer (Doc. 27).

5 Following the filing of its two motions in this Court on April 2, 2013, USAPA  
6 participated in a conference with the Bankruptcy Court for the United States District  
7 Court for the Southern District of New York on April 3, 2013. During that call, the  
8 Plaintiffs in this action were admonished by the Bankruptcy Court not to interfere with  
9 the Bankruptcy proceedings and also agreed to enter into a stipulation agreeing not to  
10 interfere with those proceedings. Based on conference and those developments, USAPA  
11 hereby withdraws the Motion to Transfer Venue (Doc. 26) and Motion to Suspend  
12 Deadlines (Doc. 27).
