 23 As set forth in the Stipulation filed by Plaintiffs regarding their request for a 12-
 24 day extension of time to file their application for attorneys' fees and costs, Defendant US
 25 Airline Pilots Association ("USAPA") had no objection to Plaintiffs' motion for an
 26 extension of their time until December 2, 2015 to file their L.R. Civ. 54.2 fee application.
 27 Doc. 338. In consenting to their request, the parties did not discuss the dates for
 28 USAPA's response to the fee application or the date for a reply.

1 The current deadline for USAPA to respond to the fee application is December 18,
2 2015 and the deadline for Plaintiffs to file a reply is January 11, 2016. Doc. 337. That
3 deadline was set when Plaintiffs' deadline was November 20, 2015. Because Plaintiffs
4 are not filing their application until December 2, 2015, USAPA needs additional time to
5 respond to the application. The same extension Plaintiffs received would make
6 USAPA's deadline to file a response December 30, 2015. However, because December
7 30, 2015 falls in the middle of the holiday season and USAPA counsel have already
8 scheduled vacation time during late December, USAPA respectfully requests that the
9 Court enter an order allowing it until Tuesday, January 12, 2016 to file its response to
10 plaintiffs' fee application. Plaintiffs consent to this request. Plaintiffs request, with
11 USAPA's consent, that the reply be due January 29, 2016.
