**NOTICE OF SETTLEMENT IN  
PRINCIPLE AND REQUEST TO  
HOLD PENDING APPLICATION  
FOR FEES IN ABEYANCE**

20 The parties hereby provide notice to this Court that they have reached a settlement  
21 in principle, and they request that this Court hold in abeyance any ruling on the  
22 *Addington* Plaintiffs' pending Application for Fees and Expenses, USAPA's Response,  
23 and Plaintiffs' Reply. [Docs. 342, 347, 348]

24 The parties recently participated in a multi-day, multi-party mediation held in  
25 Charlotte, North Carolina, as part of their good faith efforts to resolve through a global  
26 settlement all pending litigation relating to the disputes between the West Pilots and  
27 USAPA, and other related parties. The mediation was conducted pursuant to an order  
28 issued by the North Carolina District Court, where multiple matters are pending, as this  
Court may recall.

1       The parties have reached a global settlement in principle to resolve all outstanding  
2 disputes in *USAPA v. Velez*, 3:14-CV-577-RJC-DCK, *Bollmeier v. Hummel, et al.*,  
3 3:15-cv-00111-RJC-DCK, and *Bollmeier v. Frear, et al.*, 3:14-CV-577-RJC-DCK,  
4 (LMRDA action II)(consolidated in the District Court, Western District of North  
5 Carolina), and the *Addington* Plaintiffs' claim for fees and expenses pending in this  
6 Court in *Addington v. USAPA*, 2:13-CV-00471-ROS.

8       Because USAPA and its officers and directors are currently subject to an  
9 injunction entered by the North Carolina District Court that limits USAPA's ability to  
10 expend funds and to dissolve, the parties must present the settlement to the North  
11 Carolina District Court for final approval, as part of what the parties anticipate will be a  
12 fairness determination. It is anticipated the proceedings in North Carolina will take  
13 place in mid-April, 2016. Once approval of the settlement is given by the North  
14 Carolina District Court, which will include payment by USAPA on the *Addington*  
15 Plaintiffs' claim for fees and expenses pending in this Court, the parties will provide  
16 notice to this Court that all pending matters have been settled and that this Court may  
17 dismiss this action with prejudice.
